CLOSE OF ENTRIES

Gate entries will close at 9:00 am on the day of the test.

ROLL CALL & INSPECTION

Roll call and inspection will be at 9:30 am each day[or at your scheduled time to run]. We will try to break up inspection times to a morning and an afternoon time so you do not have to spend the entire day on site if you choose. We will assign your run on a first come basis and will let you know by email [if pre-entered] when you need to be at the field.

Each entry will be inspected for lameness, fitness to compete, and females in season. If in the opinion of the inspection committee, any entry found to be lame, unfit to safely compete or a female in season, that dog shall not be allowed to enter and entry fees shall be refunded.

ELIGIBILITY

Coursing Ability Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. **Females in season may not enter**. A dog may enter only once per event. (An event is defined by an event number.)

THE COURSING ABILITY TEST (CAT)

The Coursing Ability Test (CAT) is a pass/fail event. Dogs run singularly. In order to pass, the dog must complete the course with enthusiasm and without interruption within the maximum amount of time for the course length. The judge keeps the official time and decides the merits of the dog's performance.

COURSE DISTANCE & QUALIFYING TIMES


Safety of the dogs is of the utmost importance. Dogs will run one of the following course distances:

- <u>300 yard course</u> for dogs that are shorter than 12 inches at the withers and/or brachycephalic ("flat-faced"). The course must be completed in less than 1-1/2 minutes.
- 600 yard course for all dogs that do not run the 300 yard course. The course must be completed in less than 2 minutes.

If there is a question which course a dog should run, the judge will decide.

* We reserve the right to alter the course plan on the day of trial depending on field conditions.

RIBBONS

Each dog that passes the test will receive a ribbon that is orange in color.

NEW TITLE MEDALLION

The Greater Twin Cities Afghan Hound Club offers a New Title Medallion when you complete your Coursing Ability Title.

TITLES

Dogs can earn three titles by passing the Coursing Ability Test the required number of times. These are suffix titles that will appear on a dog's pedigree with a higher level title superseding a lower level title.

- <u>Coursing Ability (CA)</u> Awarded to a dog that passes the Coursing Ability Test three times under at least two different judges.
- <u>Coursing Ability Advanced (CAA)</u> Dog passes the Coursing Ability Test a total of ten times.
- <u>Coursing Ability Excellent (CAX)</u> Dog passes the Coursing Ability Test a
 total of 25 times. Coursing Ability Excellent 2 (CAX2) Dog passes the
 Coursing Ability Test a total of 50 times. A higher numbered title will be
 awarded for every additional twenty five passes.

CONDITIONS OF ENTRY

- BITCHES IN SEASON AND LAME HOUNDS WILL BE EXCUSED and entry fees shall be refunded.
- 2. All entries must be one year of age or over on the day of the test/trial.
- 3. A fee of \$25.00 will be assessed for any returned checks.
- 4. Dogs must be ready for judging. Judges need not wait for dogs holding up a TEST.
- Dogs not present at the time of Roll Call will be scratched after a 5-minute grace period.
- 6. Muzzles are not required, but are permitted at the handler's discretion
- 7. There will be a \$5.00 fine assessed for any loose hound on the field not taking part in course in progress.
- 8. Battery powered continuous loop equipment will be used including backup equipment.
- The field committee reserves the right to alter the course depending on the field and other conditions.
- 10. The field is fully fenced and fairly level with groomed, mowed, watered lush grass.
- 11. Any person upon reasonable complaint may be asked to leave the grounds by the field committee. Children **must** be under the control of their parents or guardian at all times.
- 12. Only the lure operator, huntmaster, judges, photographer, and handlers of the course in progress will be permitted near the lure operating equipment and on the field.

NOTE ON ENTRIES

- Incomplete, unsigned, conditional or unpaid entries CANNOT be accepted, so please complete your entries carefully.

DRIVING DIRECTIONS

From St. Paul / East Metro: I-694 North to US Highway 10 westbound via EXIT 42B toward ANOKA. Remain on US 10 past Anoka, toward Elk River for a total of about 18 miles. Turn RIGHT onto ARMSTRONG BLVD NW/ County Road 83 and stay on that road for 4.3 miles. Turn LEFT onto 173RD AVE NW. Then an immediate left onto Baugh St NW.

From the Minneapolis Metro South, Southeast and Southwest: Take I-94 northbound to US 169 North to US 10 (when you get to Main Street in Anoka continue to go straight across Main Street. You will be on Ferry Street for about 4 blocks until you are at US 10). Turn left on US 10 and go about 4.5 miles. Turn Right on Armstrong Blvd. NW (AKA CR-83) and go about 4.3 miles. Turn Left onto 173rd Avenue NW and then an immediate left onto Baugh St NW.
